





Parliamentary Forum and the Eighth G20 Parliamentary Speakers' Summit (P20) 5 - 7 October 2022 Jakarta, Indonesia

GENERAL INFORMATION

1. MEETING DATES AND VENUE

The Eighth G20 Parliamentary Speakers' Summit (P20 Speakers' Summit) will be hosted by the House of Representatives of the Republic of Indonesia in close cooperation with the Inter-Parliamentary Union (IPU) on Thursday, 6 October and Friday, 7 October 2022. The Summit will be preceded by an open Parliamentary Forum on 5 October to which all delegation members are warmly invited.

2. PARTICIPATION AND REGISTRATION

Participation

Only Speakers of Parliament of G20 members and guest countries, and observer parliamentary and inter-governmental organizations, are invited to attend the P20 Speakers' Summit. The Speakers of both houses of bicameral legislatures are welcome to attend. If Speakers are unable to attend, they may designate a deputy Speaker or other high-level parliamentary leader as their representative.

In keeping with the COVID-19 pandemic protocol, only four (4) delegates from each house of parliament will be allowed in the conference meeting room. Additional delegates can follow the proceedings from a viewing room (with a live video broadcast of the conference).

Registration

3. ID CARDS

ID cards will be prepared based on the information received in the Registration Form sent to the organizer's official email or to the participating parliament's Embassy in Jakarta. They will be issued at the registration desk at the conference venue which will open one day before the conference.

Security will be strictly controlled during the P20 Speakers' Summit and only ID card holders will be permitted to enter the conference venue. Therefore, all delegates will be required to wear their ID card at all times during the official programme.

Please always carry your passport with you for security reasons.

4. VISA REQUIREMENTS

All delegates must have a valid passport, with an expiry date at least six (6) months after the date of entry into the territory of Indonesia, and must ensure that the passport contains sufficient blank pages for stamps on entry into and exit from the territory of Indonesia.

Delegates can use either diplomatic, service, or ordinary passports to enter Indonesia. The Indonesian Government has a short visit visa-free agreement with several countries for diplomatic and service passport holders. The list of Agreements on Mutual Visa Exemption between the Republic of Indonesia and foreign countries can be found at http://kem.lu/visaddservice.

- Delegates nationals of countries listed in the above link can enter Indonesia without a visa using a diplomatic or service passport. These delegates must bring the approved delegation accreditation letter from the House of Representatives of the Republic of Indonesia, a travel insurance document covering COVID-19, and show a vaccination certificate through the Indonesian PeduliLindungi App.
- Delegates from countries not listed in the Mutual Visa Exemption List and using ordinary
 passports must apply for a visa and must include the accreditation letter in their visa
 application. Delegates are strongly advised to apply early through the Embassies and
 Consulates of the Republic of Indonesia accredited to or stationed in the respective member
 countries. Delegates who are ordinary passport holders may apply for visas online through

- For UN passport holders, please kindly check with the nearest Indonesian Embassy regarding your visa terms and conditions.

5. WORKING MODALITIES AND SPEECHES

The opening session is followed by four sessions of the P20 Speakers' Summit. There will be three (3) sessions on Thursday, 6 October, and one (1) session on Friday, 7 October. Since each session will feature a different agenda, please select the agenda item(s) under which you wish to speak in the order you indicate on the Registration Form and submit it to the organizer's official email address: p20indonesia@dpr.go.id no later than 9 September 2022.

For each session, two or three Speakers of Parliament will be invited to deliver keynote speeches. The selection will be made by the host Parliament in consultation with the IPU, based on the preferences indicated in the Registration Form. Each statement shall be limited to seven (7) minutes. Final adjustments will be made at the discretion of the Speaker of the House of Representatives of the Republic of Indonesia.

After the keynote speeches, the host Chairperson will give the floor to other delegates for their interventions, taking into account the registrations received for each agenda item. Statements shall be limited to three (3) minutes.

To provide as accurate an interpretation as possible during the summit, delegates who plan to speak are requested to submit a written copy in English to the liaison officer by 1 October.

6. LANGUAGES

The official languages of the P20 Speakers' Summit are English and French. Interpretation will be provided in English, French, Spanish and Arabic.

7. OUTCOME DOCUMENT

A preliminary draft outcome document (Joint Statement) will be circulated to all invited parliament in early August.

(1) Amendments to the draft Joint Statement

Delegations that wish to propose amendments to the preliminary draft Joint Statement are invited to submit their specific language proposals (bold for new language, strikethrough to delete existing language) by email to the IPU Secretariat (Cc: Indonesian organizing committee) at the email addresses below no later than <u>10 September 2022</u>. Please be sure to include a brief explanation for each proposed amendment.

A compilation of the proposed amendments, as well as a revised draft Joint Statement will be circulated in advance of the P20 Speakers' Summit.

(2) Meeting of delegation secretaries to finalize the draft Joint Statement

A meeting of delegation secretaries to finalize the draft Joint Statement will be held virtually during the <u>week of 26 September 2022</u>. No substantial amendment can be made after this meeting, so please be sure that a responsible staff member from your delegation attends this meeting. Organizational details about this meeting will be provided in due course. If needed, an additional meeting of delegation secretaries will be held on-site in the late <u>afternoon of 5 October</u>, to resolve any outstanding issues.

The draft Joint Statement will be adopted during the closing session of the P20 Speakers' Summit on Friday, 7 October.

8. **PHOTOGRAPHS**

Photographs can be taken only by delegation staff who have been authorized to enter the conference venue and they can take photographs as long as it does not interfere with the smooth running of the conference. Delegates without access to the conference venue will not be permitted to enter to take photographs.



The host Parliament will provide an arrival and departure service at the Soekarno Hatta International Airport, Jakarta (CGK).

12. TRANSPORTATION SERVICES

The host Parliament will provide a dedicated car for the Head of Delegation. The car will be available upon arrival and for departure to and from the Soekarno Hatta International Airport to the official hotels, and for transportation from the official hotels to the summit venue.

For other delegates, there will be bus services for transportation upon arrival and departure to and from the Soekarno Hatta International Airport to the official hotels. Shuttle services will be available from the official hotels to the summit venue throughout its duration.

14. LIAISON OFFICER

Each country will be assigned a liaison officer. The list of liaison officers together with their contact information will be made available to the delegations and their respective Embassies in Jakarta at a later date. In principle, future contacts with a delegation or their respective Embassy in Jakarta will be made through the liaison officer.

15. SECURITY

The host Parliament will take the necessary measures to ensure the security and safety of Speakers of Parliament and other Heads of Delegation, delegates, guests, as well as of their belongings, during the P20 Speakers' Summit.

16. COVID-19 REQUIREMENTS

The Indonesian authorities are putting in place a series of measures to ensure a safe and healthy environment for all persons attending the P20 Speakers' Summit. 19. OTHER INFORMATION

(1) Time zone

Indonesia is divided into three time zones:

- Western Indonesian Time (GMT + 7): Sumatera, Jakarta, Java (West, Central, and East), West and Central Kalimantan
- Central Indonesian Time (GMT + 8): Bali, Sulawesi, Lesser Sunda Islands, East and South Kalimantan
- Eastern Indonesian Time (GMT + 9): Maluku Islands, Irian Jaya / Indonesian Papua

(2) Climate

Indonesia has a tropical climate with high humidity. The average temperature is $24 - 31^{\circ}$ Celsius or $75 - 87^{\circ}$ Fahrenheit.

(3) Electricity

The power supply in Indonesia is 230 volts, 50 Hertz. The sockets usually contain two round-pin sockets (Type C/F). If you have electronics that run at a lower voltage, or with different plug types, you will require a converter. If you bring an adapter from abroad then make sure that it fits into a round socket. Some adapters come with a square plug which would not fit into the sockets in Jakarta because the sockets go slightly into the wall and are flat and even with the wall.

(4) Currency exchange

Indonesia's national currency is the Rupiah (Indonesian Rupiah = IDR). The exchange rate normally fluctuates between IDR 14.699 and IDR 14.882 for US\$ 1 as of June 2022.

Although Indonesian banks and money changers deal in almost all currencies, it is advisable to bring notes or traveler's cheques in the major currencies. All major credit cards (Visa, Master Card, and American Express) are widely accepted.
